Black Orchid Gynarchic Society BOGS Card Agreement

The following is a legally binding Agreement and upon your signature you hereby agree to, acknowledge, understand, affirm, and attest to the following:

1. I subscribe to the principles of the First Amendment, whereas people have the right to peacefully assemble and express themselves.
2. If a court of competent jurisdiction deems any portion of this agreement unenforceable it shall not affect the enforceability of the other portions of the agreement.
3. Black Orchid Gynarchic Society may hereafter be referred to BOGS or Black Orchid.
4. I affirm I am a safe, sane, and consensual adult over the age of twenty-one and capable of entering into this legal agreement.
5. I affirm I am neither a law enforcement officer, postal official, private investigator, nor operating under an assumed name or in cooperation with any federal, criminal, media, legal or family service investigation.
6. I am not seeking out evidence that may serve as the basis for any charge of violating federal, state, local laws nor ordinances.
7. I am not seeking to entrap or gather information for any legal, criminal, media related, or family associated issue(s).
8. I am responsible for false disclosure and accept the legal ramifications and any legal fees occurring from such action.
9. I agree I will not misrepresent my identity or impersonate anyone.
10. I affirm I will not disclose any information nor make an implication of any activity since this is a private group of people.
11. I will not disclose any information about activities, people, gifts, tributes, reimbursements, dues, fees, or donations.
12. I accept that I am under the strictest confidentiality agreement. By petition of court I would refuse to disclose any information regarding any location, association, activities, people and/or conversations except when in regards to illegal activity.
13. I am applying for a card ONLY for my own personal entertainment, development, training, education, or spiritual understanding.
14. I agree to not speak with any media person, governmental, law enforcement (state, local, nor federal) officer, nor private investigator, nor any one from a social service nor division of family services in regards to any type of activities that are promoted, seen, heard, or experienced by yourself and/or by others of the Black Orchid.
15. I agree to not speak with any media person, governmental, law enforcement (state, local, nor federal) officer, nor private investigator, nor any one from a social service nor division of family services in regards to any person, location, type of activity, things seen, heard, or experienced by yourself and/or by attendees.
16. As part of this Confidentiality Agreement, I affirm I may legally decline to answer questions, using my Fifth Amendment rights.
17. I affirm I will not disclose any information nor make an implication of any activity whatsoever.
18. BOGS will keep personal information confidential. We shall use the provided information for the reason the information was intended and never sell your e-mail address.
19. I will not disclose personal identifying information or photography belonging to anyone other than myself.
20. I understand that parties or events may be held in a private home.
21. I will not disclose any events not location that may be held at a public establishment such as a restaurant, hall, or hotel.
22. I shall never visit a house(s) unless invited and in having a confirmed RSVP number.
23. I hereby state that I am not currently nor have I participated in illegal activities of any sort.
24. I affirm that I have never been convicted for nor am in trail regarding any criminal act including but not limited to domestic violence, child abuse, homicide, infanticide, pedophilia acts, zoophilia, drug or alcohol trafficking, proxenetism nor any other illegal activity.
25. Any domestic violence, child abuse, pedophile, zoophile and illicit practices, publishing, discussions, editions, or activities shall not be introduced or presented in any manner. Such actions will be reported to authorities.
26. At our sole discretion, BOGS may determine that law enforcement officials should be notified. In doing so we may provide any and all information we have and cooperate full with the appropriate officials without notice to you. We retain the right to disclose to enforcement officials information, personal identification information, and Internet Protocol addresses pursuant to a subpoena or

court order or, in circumstances where we deem appropriate.

27. For the benefit of all attendees I understand that those suspected of any criminal actions shall be reported.
28. Anyone suspected at any time to not be of sound mind, will be dismissed and will vacate the premises immediately.
29. I understand that the hostess and/or the premise owner(s) retain right to refuse entrance to anyone for any reason.
30. I agree to never bring any illegal content or items nor discuss illegal activities during a party or event.
31. I understand that no illegal material, substances, drugs, knives or weapons of any kind are allowed.
32. No illegal activities of any sort may occur at a BOGS party/event. If suspect of an illegal activity you will be reported.
33. Paid reservations/reimbursements will be forfeited if you do not attend; they are non-refundable and non-transferable.
34. Parties, classes and all events of any kind have a registration process. No one without a pre-paid registration will be allowed.
35. All applications, event, classes/workshops, registration and administration fees are nonrefundable.
36. BOGS reserve the right to refuse entrance to any class, workshop, training, party, event, or club for any reason.
37. I understand the nature of workshops, lectures, and events may be adult oriented and state I shall find no offense.
38. BOGS retain all copyrights. All rights reserved. All trademarks remain the property of the respective owner(s).
39. A BOGS Card is necessary for access to any BOGS event.
40. A BOGS card (which BOGS can retain for you if you wish) proving age and identity will be demanded to be shown at your arrival of BOGS parties/events. The card number will be checked against the event guest list.
41. Participation and entrance will be denied if no valid ID can be presented with your BOGS Card. Paid reservations will be forfeited, as they are non-refundable.
42. BOGS parties and events have a registration process. No one without a guest list confirmation number will be allowed.
43. BOGS and the property owner(s) are not responsible for your stolen, lost, or damaged items.
44. I understand that different events may have different dress codes but that in all public places I shall be dressed appropriately.
45. Cameras, cell phones, and audio equipment are prohibited! I affirm I will not attempt to nor obtain any audio or visual record.
46. Waiver, Indemnity Release: I hereby release BOGS and our affiliates, officers, and employees from any and all claims, demands, debts, obligations, damages (perceived, actual or consequential), costs, and expenses of any and all kinds whatsoever, whether known or unknown, suspected or unsuspected, disclosed or undisclosed, that I may have against them arising out of or in any way related to such disputes. I hereby agree to waive all rights and laws that may limit the efficacy of such releases.
47. I agree to indemnify and hold BOGS, our associates, affiliates, or any person related to us harmless against any and all claims and expenses arising from any association with us.
48. BOGS expressly disclaim any and all liability arising from association with us.
49. BOGS is not responsible in any manner for your actions, the actions of others, or the transactions you may enter into and therefore you hereby state that you accept full responsibility upon yourself.
50. I accept that BOGS is not liable for any conduct by anyone.
51. I accept that BOGS is not responsible for any typographical errors, omissions, or information.
52. There is no guarantee of honesty, sincerity, accuracy, correctness, or completeness of any information.
53. I accept that BOGS is not responsible for the actions or lack of action from any person, service, or entity.
54. I accept that BOGS does not make any recommendations or give any advise in any manner.
55. In any and all cases I hold the homeowner(s) or building owner(s) harmless and will pay for any and all legal actions in regards of the premise, injury, and/or activities.
56. To the fullest extent permitted by law, we disclaim any and all warranties, be they expressed or implied, with respect to any content, information, services, safety, or products provided through or in conjunction with us.
57. There is no implied, express representations, or warranties about BOGS, associated events, nor people.
58. I accept that BOGS is not responsible for any injury, loss or damage arising from your association with us.
59. I accept that BOGS is not liable due to the use, or misuse, nor performance or non-performance in any way.
60. BOGS is not responsible for any damage caused by 'acts of God', nature, equipment failure, loss of access, any failures, delays, or interruptions in the delivery of any content or service, deletion of, failure to store, failure to back up, or in regards to content.
61. I agree that my association with BOGS is entirely at my own risk.
62. I hereby give full consent to partake in any and all activities at my own risk including but not limited to activities of giving and/or receiving intense sensations, role-playing and/or an exchange of power.
63. I accept that it is my responsibility to check things, furniture and equipment for safety and hold all others harmless.
64. If something may be or seems to be a hazard I shall report it immediately.
65. If something is broken by me or in association with me, I agree to immediately pay full retail price for the item to be replaced.
66. I waive all responsibility for any injury that I may receive during any and all activities and/or events.
67. I release and discharge the premise owners from any and all liability that might arise.
68. I release and discharge those individuals I meet from any and all liability that might arise.
69. I accept full responsibility upon myself in all regards.

70. I understand there will be security to check identification, which must be respected and obeyed.
71. Smoking is allowed only in designated areas.
72. I will not harass, coerce, or attempt to intimidate anyone, in any manner, for any reason.
73. I will always ask before I touch a person or someone's items, gear, furniture or equipment.
74. I will respect the activities of those around me; not distracting or interrupting in anyway.
75. I am solely responsible for my own health concerns and waive all responsibilities from all others.
76. I understand if I have an allergy it is my own responsibility to be sure I am not affected by said allergy.
77. I, and my heirs or representatives, waive the right to issue suit against any person, entity or the homeowner(s) in regards to any issue and/or person.
78. I willingly agree that any legal fees occurring from my action(s) directly or indirectly shall solely be my responsibility.
79. In any and all cases I hold harmless the building owner(s) and will pay for any and all legal actions in regards of the premise, injury, and/or activities.
80. Black Orchid is a private group of people with the same like mind that Females are superior beings to be served.
81. I declare that I believe Females should rule over all actions of males.
82. Each cardholder shall participate with the mindset that all Females rule over men, in all cases. This Female Dominance shall include practices where men shall be submissive, will obey, submit, devote, and respectively serve Women.
83. I believe that adult expressions of Gynarchy are a private matter between consenting adults.
84. I agree that all activities of the BOGS shall be lawful private acts between consenting adults.
85. No male dominates or 'switches' shall be allowed as cardholders.
86. BOGS gatherings are private and personal where the philosophy of Female Supremacy is practiced.
87. Men agree to exhibit polite manners at all times as well as those in BOGS.
88. Men agree to respect and assist all Women as well as those in BOGS.
89. Men shall obey the Woman who rules them as well as those in BOGS.
90. Men shall not be selfish but shall work towards the benefit of family, Women, and BOGS.
91. Women will endeavor to use support systems such as family, church, BOGS, and BOMS.
92. All Card Holders will follow the Gynarchic Hierarchy Structure, Principals, and Rules as posted at <http://bogs.matriarchsociety.com>
93. I agree that it is my duty to insure BOGS high standards and reputation.
94. I shall help everyone maintain all rules and conditions.
95. Every one is responsible to be sure that sight and sound barriers are in place.
96. I agree not to make unreasonable amounts of noise and will remind others of the same but without being interruptive.
97. If you are in violation of this agreement, you are solely responsible for your actions as well as being financially obligated for all damages, fees, and financial matters in association with prosecution, and such damages including but not limited to damages resulting from loss of revenue and/or property, fines, slander, imprisonment, and attorney's fees, including without limitation, those generated by prosecution and/or governmentally imposed seizure(s), forfeiture(s), and/or injunction(s).
98. Any infraction of this agreement will constitute termination of the BOGS card but will not release you from this Agreement.
99. Reporting a Violation of these Terms of Service: We should be informed of any violation of the Terms and Conditions. If you believe there is a violation you should contact us so that your concern may be reviewed. We are under no obligation to take any action and if any action is taken it shall be at our sole discretion.
100. This Agreement is entered into in St. Louis, Missouri. You agree that Missouri law (regardless of conflicts of law principles) shall govern this Agreement, and that any dispute arising out of or relating to this Agreement shall be subject to the federal and state courts in St. Louis, Missouri. All judgments and interpretation concerning the application and enforceability of these Terms and Conditions are made at our sole and absolute discretion.
101. All disputes and respective assigns, attorneys, and successors of any kind whatsoever, arising from this agreement shall be resolved by arbitration in accordance to the rules of the American Arbitration Association. Arbitral claims shall include, but are not limited to, tort and contract of all kinds, and all claims based on federal, state, or local statute, laws and regulations. Arbitration shall be final, binding and the exclusive remedy for all parties for all claims with the fees of the arbitrator being paid for by the losing party, as determined by the arbitrator.
102. BOGS reserve the right to update, revise, or enhance this agreement. Any and all alterations and revisions will be posted on the web site <http://bogs.matriarchsociety.com> You will not be directly notified. These revisions shall then become a part of this agreement. The Agreement within the website shall replace all others. I accept it is my responsibility to check the website to see if changes have occurred. Failure to cancel your BOGS card within fifteen (15) days of the dated revision indicates your complete acceptance of revised Agreement.
103. To cancel your BOGS card, send a copy of your photo ID, or other means of identification, with your request to cancel your card. Postal Mail to: BOGS - P.O. Box 142804, St. Louis, MO 63114. Canceling your card will remove you from any BOGS listings on site.
104. Cancellation of your BOGS card will not remove you from any e-mail lists or associated groups, blogs, or forums.

- 105. The Black Orchid reserves the right to immediately terminate a cardholder for any illegal activities or such suspicions because it could harm the image of Black Orchid and/or cardholders.
- 106. Black Orchid is neither a 'swingers' club nor a house of prostitution.
- 107. Prostitution is strictly prohibited.
- 108. I understand that I am not purchasing nor requesting any sexual acts or illegal activity since no sexual services are offered.
- 109. I shall not expect any nudity or acts of prostitution.
- 110. I shall not solicit sex, nudity, or any illegal act in any manner.
- 111. All transactions by all cardholders are the sole responsibility of said persons and not affiliated with BOGS.
- 112. Any interaction or transaction between a Pro-Domina and her subject is a private matter between two consenting adults.
- 113. All transactions are the sole responsibility of said persons so neither Black Orchid nor the location will be held liable in any manner.
- 114. BOGS reserves the right to refuse or revoke a BOGS Card, for any reason, at any time.
- 115. Administration Application Fee associated with cardholders and submitted with this Agreement for are non-refundable.
- 116. Valid card numbers are on file. If the card number is not valid you will not be allowed entrance.
- 117. All Card Holders must provide proof of age and identity as an adult who is at least twenty-one years old by submitting a clearly readable photocopy of your Driver's license or passport that contains the date of birth with this signed agreement.
- 118. BOGS will not accept any application without a copy of photo identification. If application and fee are received but no photo identification verifying the age is received then the application will be denied and the application fee retained.
- 119. I understand that if it appears that I am not conforming to the rules and/or standards of the BOGS or the principals of Gynarchy I will be asked to leave the premises immediately, denied entry to an event or club regardless if club/event attendance donation, reimbursement, or reservation has been paid. In this matter, again, there shall be no refund since rules where broken.
- 120. I understand if BOGS accept this Agreement that I will receive a BOGS Card Holder Form that needs to be filled out and returned in order to receive a BOGS Card.

I do hereby state I am willingly entering into this without agreement force or threat of any kind. By applying my signature below I hereby enter into this legally binding agreement, having asked for and received any clarification of any portion.

ENTIRE AGREEMENT: These Terms and Conditions constitute the entire agreement between the parties with respect to the subject matter contained herein and supersede any other agreement, written or oral.
